Honing a skill

Earful of Fiddle provides immersive camp experience



If you're an aspiring dancer or folk musician living in central Michigan, you don't have to go far to find a place where you can connect and learn with people who share your interests. Each summer, Camp Brethren Heights in Rodney is transformed into Earful of Fiddle, a five-day immersive fiddle and dance camp. For 15 years, the camp has been running under the passion and guidance of Kris and Bruce Stableford and Nic Gareiss.

In addition to learning about fiddle music and dance, Earful of Fiddle offers campers the opportunity to explore the banjo, ukulele, mandolin, and even square dance calling. And because it is not exclusively a youth camp, participants have the chance to connect across generations. In many cases, adults and children are in the same classes learning together.

The camp also attracts artists of all levels of experience. "I remember getting ready to teach an advanced dancing class and giving my students an exercise that would normally take 10 minutes for a good dancer to grasp, and they all were doing it perfectly immediately," says Nic. "I felt so privileged to be with that caliber of students who were so passionate and eager to grow."

While this unique experience draws participants from all over the country—and even some from as far as Halifax, Nova Scotia—Kris and Nic, who are both from the area, are also excited to make sure local people have the opportunities they wished they had growing up. "Growing up in mid-Michigan, there

were no places for an aspiring dancer to go," said Nic. "If you wanted to go to something like our camp, you would need to travel to the East or West Coast or even overseas."

Earful of Fiddle puts great thought and care into making their camp as accessible as possible for all participants. More than a quarter of campers receive scholarships to attend, including scholarships specifically for Black, Indigenous, and people of color as well as LGBTQ+ participants. They are also thoughtful about making their setting more accessible for people with disabilities or mobility issues.

"Camp Brethren Heights is a stunning location for hosting a camp. It offers beautiful hills and amazing views of the





lake," said Kris. "However, with that landscape also comes the difficulty of our differently-abled individuals navigating around the camp."

This year, thanks to a grant from the Community Foundation, the camp was able to rent two golf carts that were used to transport campers, volunteers, and instructors who needed assistance getting across the camp. "A large portion of the camp is on a hill, so having the carts to transport individuals was a huge blessing," said Nic. The carts served as another tool to support Earful of Fiddle's goal to continue growing and increasing their ability to be as accessible and inclusive as possible.

An evening out

Community Foundation hosts Gather and Grow event

A small gathering of community members and friends of the Community Foundation came together on August 21 at the Winery (a) Young Farms in Mecosta. At the evening event, guests were treated to dinner from Phat Matt's Food Truck and drinks from the Winery (a) Young Farms and had plenty of time to mingle and make new friends. The evening also featured live music by Mir and the Man.

"This event was a wonderful way to bring our friends together from across our communities," said Board Chair Tom Tacia. "We want to raise awareness not only for the Community Foundation, but for the dedicated nonprofits it supports."

Guests were introduced to trustees and staff, and Tom thanked Mark Young, who also serves as a Community Foundation trustee, and Abby Young for hosting the event. The event highlighted some of the Community Foundation's recent work and ways to get involved, including the Cornerstone Legacy Society and giving to the Community Needs Fund. "One of the ways we recognize individuals who have given an estate gift is through the Cornerstone Legacy Society," explained Tom. "The society was named in honor of the group of individuals who helped us start the Community Needs Fund during our cornerstone campaign 30 years ago. The Community Needs Fund is an unrestricted fund. The fund provides the Community Foundation the most flexibility to serve the needs of the community. By supporting this fund, you are directly supporting those who need help by supporting organizations who can give it."

The event also touched on an important part of the Community Foundation's mission: creating positive change in Mecosta County. "Tonight was a way for people to get to know us in a more informal environment," said Tom. "We look forward to continuing to build new relationships all around Mecosta County."



Moving our work forward

Action planning update



Over the last 18 months, the Community Foundation has developed an updated action plan to guide its work moving forward. The process has included extensive research, conversations, and community feedback.

"This work is important to give us direction and purpose," said Maria E. Gonzalez, senior director. "We want donors to be able to understand how their money will be used, and we want grantees to know what our priorities will be."

The action plan began with Fremont Area Community Foundation's strategic planning process. Fremont Area Community Foundation serves Newaygo County and hosts three affiliate foundations, including our own and the community foundations in Lake and Osceola counties. All four foundations were actively involved in the development of Fremont Area Community Foundation's four primary goals: optimize operational enhancements, promote the common good, expand philanthropy, and strengthen capacity for people and communities.

While we have adopted these goals as an overall guide for our own work, each community foundation in our fourcounty region has also developed an action plan specific to the needs, resources, and character of their own county.

"While some of our efforts happen across the region, some are very specific to the particular county," said Maria. "There are specific things we are engaging in for each area."

For Mecosta County Community Foundation, the Gather and Grow event at the Winery (a) Young Farms in August was one step in the overall goal to expand philanthropy. The event for new friends and emeritus trustees provided an avenue for fun, conversation, and an increased awareness of the work of the Community Foundation. People could learn more about our organization's efforts and how they can get involved, all while enjoying a nice evening out.

"Events, newsletters, and more storytelling are all ways we can raise awareness of the Community Foundation, expand our reach, and introduce more people to philanthropy," said Maria.

"The new strategic action plan is an important guide for our work but is also a flexible document that can change and be updated as community needs change and shift," she continued. "We are excited about having a plan that can be implemented and allow us to move forward in a strategic manner."
